

Fund Positioning

HDFC Overnight Fund is an open ended debt scheme ideal for parking surplus money pending deployment or for meeting contingencies. The fund invests predominantly in debt and money market instruments with overnight maturity. Investments under the Scheme would be made predominantly in Collateralised Borrowing & Lending Obligations (CBLO), overnight reverse repos and fixed income securities / instruments with overnight maturity.

Investment Objective

To generate returns by investing in debt and money market instruments with overnight maturity. There is no assurance that the investment objective of the Scheme will be achieved.

(ii) No Exit load will be levied on bonus Units and on units allotted on Re-investment of Income Distribution cum Capital Withdrawal. (iii) No Exit load will be levied on Units allotted in the Target Scheme under the Transfer of Income Distribution cum Capital Withdrawal (IDCW) Plan Facility (TIP Facility). (iv) In case of Systematic Transactions such as Systematic Investment Plan (SIP), Flex Systematic (Flex STP), HDFC Swing Systematic Transfer Plan (Swing STP), HDFC Flexindex Plan (Flexindex) etc., Exit Load, if any, prevailing on the date of registration / enrolment shall be levied.



Portfolio Classification by Asset Class (%) as on February 28, 2026




